

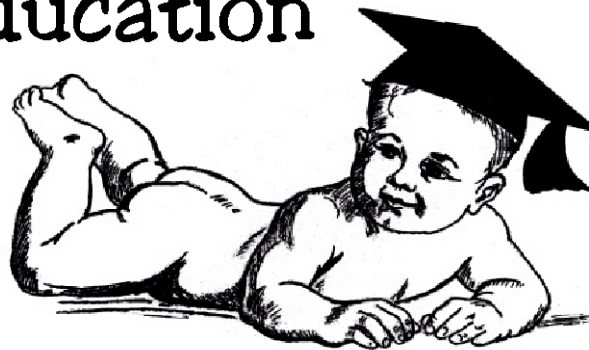
## AANR Education Foundation, Inc.
